

## Notice of Special Election—February 3, 2009

This election is being conducted entirely by mail.

Every eligible voter in Thurston County should have received a ballot for this election. Voters who have not yet received a ballot, should come to the Auditor's Office at 2000 Lakeridge Drive SW, Olympia, Washington 98502 to receive a replacement ballot. The Auditor's Office is open from 8:00 a.m. to 5:00 p.m. Monday through Friday, except for Election Day, Tuesday, Feb. 3, 2009 when the office will be open from 7:00 a.m. to 8:00 p.m.

This sample ballot contains the ballot measure certified to appear on the Feb. 3, 2009 Special Election Ballot. If you choose to mail your ballot, return postage is required. If you are using a ballot drop box, no postage is necessary.

### Timberland Regional Library District Levy Lid Lift

The Timberland Regional Library Board of Trustees adopted Resolution No. 08-05 proposing to increase the District's regular property tax levy. This proposition would restore the District's regular property tax levy for maintenance and operations to a maximum of \$.50 per \$1,000 assessed valuation for collection in 2010 and to establish the newly approved maximum levy amount as the basis for calculating future property tax levies.
