LCR 0.1 – 0.6	Recodified LCR 0.2 to LGR 29 and recodified LCR 0.5 to LCR 77. Repealed the remaining portions.
LCR 1	New rule regarding scope of local civil rules.
LCR 3	Recodified from LCR 16 and LCR 40.
LCR 4	Repealed.
LCR 5	Eliminated redundancies and restructured. Note new section (d)(2)(B) regarding electronic submission of working copies.
LCR 7	Recodified from LCR 16, restructured, and eliminated some material.
LCR 10	Restructured.
LCR 11	Conformed to state-wide CRs. Moved the "sanctions" section from LCR 83.
LCR 16	Except the pretrial procedure section, recodified to LCR 3, LCR 7, and LCR 59. Section (c) is the court's procedure for Public Records Act cases.
LCR 40	Recodified a large portion of this rule to LCR 3
LCR 41	Conformed title and numbers with CR 41.
LCR 43	Repealed.
LCR 47	Repealed.
LCR 51	Restructured and conformed title and numbers with CR 51.
LCR 54	Repealed.
LCR 56	Conformed to CR 56 and eliminated section (a).
LCR 59	Repealed most of the rule and recodified the family court reconsideration and revision sections to LSPR 94.14.
LCR 65	Recodified from LCR 16 and simplified significantly.
LCR 77	Recodified from LCR 0.5. See in particular LCR 77(o)(2)(B).

LCR 80	Conformed to CR 80. New content regarding who can transcribe electronic recordings.
LCR 83	Repealed (a) and (b)(2), recodified civil sanctions in LCR 11. This eliminates LCR 83 entirely.
