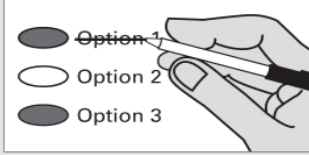

## State Measures

### Initiative Measure No. 1125

Initiative Measure No. 1125 concerns state expenditures on transportation. This measure would prohibit the use of motor vehicle fund revenue and vehicle toll revenue for non-transportation purposes, and require that road and bridge tolls be set by the legislature and be project-specific.

### Senate Joint Resolution No. 8205

The Board of Fire Commissioners of Fire Protection District No. 3 Thurston County, Washington, (Lacey Fire District 3) adopted Resolution No. 812-08-11 concerning a proposition to restore the District's regular property tax levy. The proposition would authorize the District to restore its regular property tax levy to an amount not to exceed \$1.50 per \$1,000 of assessed value for collection in 2012 to pay increases in operational costs, and set the limit factor at 106% for each of the five succeeding years (2013-2017). The 2017 levy amount will be used to calculate subsequent levy limits.
