**CENTRALIA SCHOOL DISTRICT NO. 401-L  
PROPOSITION NO. 1  
EDUCATIONAL MAINTENANCE AND OPERATION LEVY**

To replace an expiring levy, the Centralia School District No. 401 Board of Directors adopted Resolution #2005-17 concerning educational funding. **NORTH THURSTON PUBLIC SCHOOLS  
PROPOSITION NO. 1  
GENERAL OBLIGATION BONDS - \$112,000,000**

The Board of Directors of North Thurston Public Schools adopted Resolution No. 674 concerning a proposition to issue general obligation bonds. The proposition would authorize the district to modernize, improve, expand or equip district elementary, middle, high school and other facilities, construct a new school and acquire property to accommodate growth, acquire equipment for safety, and make other capital improvements, and issue \$112,000,000 of general obligation bonds maturing within a maximum of 20 years, and levy property taxes annually, in addition to regular property tax levies, to repay such bonds, all as provided in Resolution No. 674.
