Election Result Information

- Ballots will begin being run through tabulation machines at 7:00 a.m. and again at 6:00 p.m. on Election Day. Computer printouts of election results will not be available on Election Night until shortly after 8:00 p.m.
- Additional counts will be conducted daily (weekends and holidays excluded) as required by law. Daily counts will ***begin*** at 6:00 p.m. on August 20 and 21, and will begin at 4:00 p.m. thereafter.
- The final certification count will begin September 3, at 11:00 a.m.
- Count times indicated represent the start times for each count. Updated results will be available after all processed ballots have been run. Counts are subject to cancellation if the Auditor's Office is not in possession of at least 500 valid, processed ballots at the scheduled time.

City of Olympia
Proposition No. 1
Fire Department Acquisition and Improvement Bonds - \$16,500,000

The City Council of the City of Olympia passed Ordinance No. 6554 concerning this proposition. This proposition authorizes the City to construct and equip a new fire station and a fire training center and acquire two fire engines and a ladder truck, issue general obligation bonds in the principal amount of \$16,500,000, maturing within a maximum of twenty years from date of issue, and levy property taxes annually in addition to regular tax levies to repay such bonds, all as provided in Ordinance No. 6554.

Proposition No. 1
Levy Lid Lift

The Board of Fire Commissioners of Fire Protection District No. 3, Thurston County, Washington, (Lacey Fire District 3) adopted Resolution No. 788-05-08 concerning a proposition to restore the District's regular property tax levy. The proposition would authorize the District to restore its regular property tax levy to an amount not to exceed \$1.50 per \$1,000 of assessed value for collection in 2009 to pay increases in operational costs, and set the limit factor at 100% plus the annual percentage change in the Consumer Price Index (as identified in the Resolution) for each of the five succeeding years (2010 – 2014). The 2014 levy amount will be used to calculate subsequent levy limits.
